- I understand that I am responsible for the safety of the vehicle and its passengers;
- If the vehicle is stolen alert The Company within 24/hrs;
- I accept responsibility for any traffic infringements (e.g. Speeding fines, parking fines and red light camera fines) whilst the abovementioned vehicle is in my care and control;
- I accept any tolls incurred on motorways, city link roads or bridges will be at my own expense;
- If involved in an accident, I will record and provide the other party’s particulars, including Driver’s Licence number and insurance company details and pay any policy and age excess where applicable;
- I have inspected the motorcycle/vehicle prior to signing this agreement and have checked they are in a satisfactory and safe condition and fit for purpose;
- I agree to not take the motorcycle/vehicle to the track or ride the motorcycle/vehicle on the track;

- I will notify The Company within 24/hrs if the motorcycle/vehicle breaks down or requires servicing;
- I understand that the loan of the motorcycle/vehicle does not in any way constitute ownership of this motorcycle/vehicle;
